सम्बद्धता आदेश

असाधारण गजट नोटिफिकेशन संख्या-९७५/७९- वि-१-१४-१(क)१९/२०१४ दिनांक १८.०७.२०१४ द्वारा उत्तर प्रदेश राज्य विश्वविद्यालय अधिनियम १९७३ की धारा-३७ की उपधारा-२ द्वारा प्रदत्त अधिकार के तहत माननीय कुलपति जी के आदेशानुसार कार्यपरिषद की स्वीकृति के आलोक में कृष्णा कालेज ऑफ एजुकेशन, कमालपुर, छुटमलपुर, जिला-सहारनपुर को शिक्षा संकायान्तर्गत स्नातक स्तर पर बी०ए० पाठ्यक्रम (५० सीट) में स्ववित्त पोषित योजनान्तर्गत निम्नलिखित शर्तों के अधीन दिनांक ०१.०७.२०१८ से सम्बद्धता की पूर्वानुमति प्रदान की गयी है।

०१. संस्था द्वारा उ०प्र० राज्य विश्वविद्यालय (संशोधन) अध्यादेश, २००३ द्वारा मूल अधिनियम, १९७३ की धारा-३७(२) में प्राक्कानित परन्तुक के अनुसार बी०ए० पाठ्यक्रम में प्रवेश से पूर्व उपरोक्त संदर्भित कमियों का निराकरण कर लिया जायेगा एवं सभी निर्धारित मानकों को पूर्ण कर लिया जायेगा अन्यथा सम्बद्धता आदेश स्वतः निरस्त माना जायेगा।
०२. संस्थान/महाविद्यालय सशर्त सम्बद्धता/सम्बद्धता आदेश में इंगित कमियों की पूर्ति कर लेगा एवं विश्वविद्यालय के कुलसचिव को इस आशय का प्रमाण पत्र प्रतिवर्ष प्रेषित करेगा कि संस्थान/महाविद्यालय सम्बद्धता की शर्तें निरन्तर पूरी कर रहा है।
०३. संस्था शासनादेश संख्या-२८५१/सत्तर-२-२००३-१६(९२)/२००२ दिनांक २ जुलाई २००३ में उल्लिखित दिशा-निर्देशों एवं इस विषय में समय-समय पर निर्गत शासनादेशों का पालन करेगी। रिट याचिका संख्या-६१८५९/२०१२ में पारित आदेश दिनांक २०.१२.२०१२ के अनुपालन हेतु मानकानुसार शिक्षकों के अनुमोदन/नियुक्ति के सम्बन्ध में निर्गत शासनादेश संख्या-६२२/सत्तर-२-२०१३-२(६५०)/२०१२ दिनांक ३० अप्रैल, २०१३ का अनुपालन संस्थान/महाविद्यालय द्वारा सुनिश्चित कराया जाये।
०४. यदि संस्था द्वारा विश्वविद्यालय की परिनियमावली/अध्यादेश में वर्णित तथा शासन एवं विश्वविद्यालय द्वारा निर्धारित शर्तों एवं मानकों की पूर्णता एवं उनकी निरन्तरता को सुनिश्चित नहीं किया जायेगा तो उत्तर प्रदेश राज्य विश्वविद्यालय अधिनियम १९७३ के प्राविधानों के अन्तर्गत संस्था को प्रदान की गई सम्बद्धता वापस लिये जाने की कार्यवाही नियमानुसार की जायेगी।

अतः कार्य परिषद की स्वीकृति दिनांक ०९.०५.२०१८ के आलोक में कुलपति जी के आदेशानुसार कृष्णा कालेज ऑफ एजुकेशन, कमालपुर, छुटमलपुर, जिला-सहारनपुर को शिक्षा संकायान्तर्गत स्नातक स्तर पर बी०ए० पाठ्यक्रम (५० सीट) में स्ववित्त पोषित योजनान्तर्गत उपरोक्त शर्तों के अधीन दिनांक ०१.०७.२०१८ से सम्बद्धता की स्वीकृति प्रदान की जाती है। इसी क्रम में यह भी सूच्य है कि उक्त पाठ्यक्रम में छात्रों के प्रवेश विश्वविद्यालय के निर्देशों के अनुसार किये जायेंगे।

**RECOGNITION ORDER**

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the institutions had submitted applications to the Northern Regional Committee of NCTE for grant of recognition for Teacher Education Course.

2. AND WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by these institutions, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against letter of intent under clause 7(13) of the NCTE Regulations, 2014 (earlier 7(9) of the NCTE Regulations, 2009), the Northern Regional Committee in its 248<sup>th</sup> Meeting of the NRC held on 11<sup>th</sup> to 31<sup>st</sup>, January, 2016 (Part-12, 30.01.2016) is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the concerned Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to the following Institutions for conducting Teacher Education Course with an annual intake mentioned against their names from the academic session 2016-17 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfilment of the conditions mentioned below :-

- (vii) The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (viii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iii) The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provided that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five year of such recognition."
- (iv) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- (v) As per the provisions of the NCTE Regulations, 2014, the following norms have been prescribed for staff/ qualifications/administrative and professional staff/terms and conditions of service etc.

**NORMS AND STANDARDS FOR BACHELOR OF EDUCATION PROGRAMME LEADING TO THE BACHELOR OF EDUCATION (B.ED.) DEGREE - Regarding Staff**

**5.1 Academic Faculty**

For an intake of two basic units of 50 students each, that is total students strength of 200, there shall 16 full-time

faculty members.

The distribution of faculty across different curricular areas shall be as under:

- Note: (i) The faculty positions listed under different subject categories may teach course(s) in the Teacher Education Programme across curricular areas specified, and can cater to both foundation and pedagogy course(s). If the students strength for two years is one hundred (with one basic unit) only, the number of faculty shall be reduced to 8.
- (ii) Faculty can be utilized teaching in flexible manner so as to optimize academic expertise available.

## 5.2 Qualifications

The faculty shall possess the following qualifications:

### A. Principal / HOD

- (i) Postgraduate degree in Arts / Sciences / Social Sciences / Humanities/Commerce with minimum 55% marks; and
- (ii) M.Ed. with minimum 55% marks; and
- (iii) Ph.D in Education or in any pedagogic subject offered in the institutions; and
- (iv) Eight years of teaching experience in a secondary Teacher Education Institution.

Desirable : Diploma/Degree in Education Administration or Educational Leadership.

### B. Perspectives in Education or Foundation Courses

- (i) Postgraduate degree in Social Sciences with minimum 55% marks; and M.Ed. degree from a recognized university with minimum 55% marks.  
OR  
Postgraduate (MA) degree in Education with minimum 55% marks; and
- (i) B.Ed./B.El.Ed. degree with minimum 55% marks.

### C. Curriculum and Pedagogic Courses

- (i) Postgraduate degree in Sciences / Mathematics /Social Sciences/Languages with minimum 55% marks; and  
M.Ed. degree minimum 55% marks

Desirable : PhD degree in Education with subject specialisations.

[Note: In case of B and C put together, for two faculty positions, a postgraduate degree in Sociology/Psychology/Philosophy with 55% marks, and B.Ed. /B.El.Ed. with 55% marks and three years of teaching experience in a secondary school shall be considered].

### D. Specialised Courses Physical Education


- (i) Master of Physical Education (M.P.Ed.) with minimum 55% marks. (Training/qualification in yogs education shall be desirable)

Visual Arts

8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
